### HOXNE PARISH COUNCIL

Minutes of meeting held at Hoxne Playingfield Pavilion on Thursday 5 October 2023 at 19.30 hours

#### Present:

Cllrs Caroline Abbott, Paul Ellis Chris Parkin, Angus Herron, Bryn Lerwill, and Chris Parkin (Chairman). Also in attendance District Councillor Matthew Hicks (also representing Suffolk County Council) and Sarah Foote, Parish Clerk, and one member of the public observed the meeting.

### 1. Apologies

Apologies were received from Cllr Richard Kruszewski and accepted by the Council.

#### 2. Declarations of Interests

Cllr Parkin, Herron, Lerwill and Ellis declared they were members of the garden club but did not feel they had a registerable interest in the application.

#### 3. Public Forum

A member of the public confirmed that Suffolk Highways would remove the road narrowing sign by their property on Green Street.

Mid Suffolk District Council, Councillor Hicks —reported that a long term strategic vision survey was being carried out online as well as in person workshops to understand how the electorate wanted the council to develop over the forthcoming years. £800k Community Transport Fund available to develop sustainable transport links. Joint Local Plan has been signed off by the Planning Inspectorate.

<u>Suffolk County Council, Councillor Hicks on behalf of Councillor Gould</u> – reported on the county council budget and areas of over spend concern. National Grid plans for pylons from Norwich to Tilbury had been held to account; not enough consultation, impact on Waveney Valley, should consider offshore instead. Not acceptable scheme. Cllr Hicks encouraged all to respond to the A140 junction consultation.

- c. Hoxne Neighbourhood Development Plan final amendments were being made to the plan namely inserted photographs for landscapes and maps to support policies. It was understood the referendum may take place before the end of the year.
- d. Planning enforcement
- i. The erection of a wall at Abbey Hill was under investigation
- ii. A resident had raised concerns about the operations and scale of development at the Nine Oaks, Green Street and it was agreed this would be referred to the District Council's Planning Enforcement team.
- d. Other planning matters none.

8. Highways

- a. <u>Suffolk Highways to consider traffic calming measures for B1118</u> a meeting with the Highways Engineer was to be progressed to determine locations for data recorders to be placed.
- b. It was noted that Suffolk County Council and Mid Suffolk District Council combined funding had been offered for the data recording as referenced above.
- c. <u>Traffic Consultants' Technical Report</u> the detailed analysis and summary report were noted. It was hoped to use the data to inform future traffic calming schemes. It was asked if the Suffolk County Council data recorded before the introduction of the Temporary Traffic Regulation Order (HGV restrictions) for Eye was actioned could be obtained.
- d. <u>Purchase and installation of village gateway</u> signs Suffolk County Council had recently confirmed that the gateways could be installed if conformed to DoT drawings which meant there would need to be some changes to the original design the Parish Council had approved; capital letters and the colour of the crest. An alternative would be to put the 'Hoxne' and crest element of the sign separately to the gateway 30 mph sign. It was agreed to pursue the options further with the Highways Engineer, particularly how to retain the colour crest aspect of the original design.
- e. <u>Purchase and installation of Low Street noticeboard</u> Cllr Lerwin confirmed that NRSWA certification was needed to be able to erect the noticeboard in the chosen location, highway land adjacent to the wall of the Swan PH. Alternative options were explored but it was agreed to keep with original plan and find a highways contractor to do the work which the Parish Council would fund.

9. Asset Management

- a. Repairs to the Low Street shelter no report available.
- b. Land transfers there was no update from the lawyer.

10. Finance and Governance

- a. Receipt of the second instalment of Precept (£7,350) was noted.
- b. The external audit report for the year ending 31 March 2023 was noted and accepted.
- c. The council's current financial position was noted as £36,795.51 which included the year ending 31 March 2023 VAT reclaim of £834.49 and a CIL fund of £17,904.95.
