1. Apologies

Apologies were received from Cllrs Garnham and Gibson and accepted.

2. Declarations of Interests

Councillors were reminded of the requirement to update their register of interests as necessary.

3. Public Forum

County Councillor Peter Gould had provided his report prior to the meeting and offered to take questions. Information was available on the Suffolk County Council website to support families and individual in financial hardship and the Suffolk Leadership Group were working on initiatives to tackle poverty. A scheme to help people by solar panels 'Solar Together Suffolk' is open for new registrations. A centre of excellence for advising and responding to proposals on energy innovation was being created, hosted by Suffolk but with a remit across the east of England. Repairs to Church Hill would be carried out next week subject to the necessary permit. A new highways contract would be awarded by Suffolk County Council in 2023.

Cllr Wilby asked about the procurement process for the highways contract and for more details of what 'repairs' for Church Hill would entail.

Cllr Chimes asked about 'warmer homes' initiatives and if funding was available to support use of community buildings in the village.

Comments from the applicant for planning application DC/22/03496 were read by the Clerk.

- c. <u>Neighbourhood Development Plan</u> Cllr Marsh-Feiley reported the final revisions has been made to the NDP and this would now be printed and put forward for the inspection process.
- d. There were no other planning matters.

8. Assets

- a. Application to designate Post Office Stores as an Asset of Community Value discussion took place on the merits of registering the Post Office Stores given that it was already on the open market for sale noting that the intent of Asset of Community Value registration is to give the community a six-month period to purchase before placed on open market. It was agreed to ascertain if registration as an Asset of Community Value has any power in planning permission terms and if it would secure the Post Office Stores and prevent any change to residential.
- b. Community Infrastructure Levy (items of expenditure) this was not a standing agenda item. The possibility of cycle racks at the village hall was put forward as one possibility for use of funds. Cllr Chimes would ascertain more at the sustainable transport event she was due to attend in Eye. It was also agreed that collaborative work with Brome and Oakley Parish Council could lead to a 40 mph buffer from Hoxne to Oakley. It was agreed that a Working Group would be formed at the next meeting to consider ideas in more depth and how best to organise public consultation on ideas to be put forward.
- c. Abbey Terrace Land transfer Correspondence from the developer was noted. Should the Parish Council wish to obtain an independent legal opinion on the transfer there would be costs to be met. Cllr Chimes proposed that a full report was produced; including key relevant documents from planning permission grant going forward, including details of any planning conditions, what the developer is required to commit to and what the Parish Council seeks to obtain and any conditions which may be applied to the Parish Council in terms of management plans for the land. Cllr Chimes would commence work on this and Cllr Marsh Feiley would assist. It was recognised that the Parish Council could spend money on the project as necessary and it was hoped to work with the developer to achieve something for the village. Cllrs Marsh Feiley and Chimes would endeavour to meet with the developer on site.

9. Finance and Governance
