The Chairman and Clerk reported:

Green Street – the Design Engineer for the Local Highways Budget Team had provided a quotation for the design at a cost of £4,784 and £7,000 (maximum) for the construction. The County Councillor had commissioned the design work and stated that he considered the design fee quotation to be high and requested that it be recalculated. The design should be available by 15 March for the Parish Council to comment on. The Chairman suggested that it may be prudent for the Parish Council to consider a contribution to the scheme to a maximum of £3,000 but hoped it would be unlikely for this to be needed. There was general agreement to support the scheme and to make a financial contribution which would be subject to formal consideration at a future meeting.

<u>Maynard Trust</u> - the Clerk brought to Councillors attention the need to make nominations for appointments to the Maynard Trust from April 2017. This would be an agenda item for the next meeting. *Action: Agenda next meeting.*
